GENERAL CONDITIONS

Sandhurst Club Limited ("the Club") is seeking to attract new members through the offering of Lifetime Memberships.

This Offer is made pursuant to the Offer Document which consists of this Terms and Condition document, the Chance of a Lifetime brochure, and the Club's and Sandhurst Holdings (Australia) Limited ("the Company") Constitutions.

Under this limited offer the upfront cost of these Lifetime Memberships is \$0. All the successful applicants will need to pay is the Club's Subscription Fees, Clubhouse Levy and other applicable fees and charges ("Annual Fees")s.

A successful applicant may cancel his or her Lifetime Membership in accordance with the Club's Constitution and subject to the payment of all applicable Annual Fees plus any outstanding debt owed to the Club or Company. A Lifetime Membership entitles the member to enjoy the rights and privileges of lifetime membership of the Club and membership of the Company.

Lifetime Membership entitles the member to enjoy the following privileges, subject to the Lifetime Member continuing to pay the Annual Fees and compliance with the Company's and Club's Constitutions and By-Laws and Rules:

- entitlement to play golf at the Golf Courses 7 days per week (including full rights to use the Clubhouse and Club Facilities), subject to certain exceptions detailed in the Club's Constitution;
- exemption from the payment of green fees in respect of the Club's golf courses;
- entitlement to meals, refreshments and privileges as are provided by the Club for Golf Members, their Guests and anyone else the Club Board admits to the golf courses, the Clubhouse and the Club's facilities, at prices determined by the Club Board from time to time. A Club Lifetime Member can apply its Clubhouse Levy towards the payment of meals, refreshments and privileges, but only up to the amount of the Clubhouse Levy actually paid by that Club Lifetime Member;
- subject to the Club's Constitution and By-laws and Rules, the ability to invite guests to utilise the golf courses, the clubhouse and the Club facilities, who must comply with the Club's By-laws and Rules. Unless the Club Board determines otherwise, a particular guest may only utilise the golf courses a maximum of four times per year. In addition only three guests may utilise the golf courses on any one occasion; and
- entitlement to all other benefits conferred under the Club's and Company's Constitution and any By-laws or Rules made by the Board of the Club from time to time.

Applicants should refer to the Club's and Company's Constitutions which set out the rights, privileges and prohibitions of a Lifetime Member in more detail. Copies of these Constitutions are available from the Club or on the Club's website.

The Club Board will assess an Application for Club Membership. The Club may approve or reject an Application in its absolute discretion, and is not required to provide any reasons for its decision. This assessment will be based upon the information provided in the Application Form and any other source considered appropriate by the Club Board. The Club may also require the Applicant to attend an interview.

PRIORITY FOR ASSESSING AND APPROVING CLUB MEMBERSHIP APPLICATIONS

If the Offer is oversubscribed, the Boards of the Club and Company shall be entitled to give priority to Applicants in any order at their own discretion.

OPENING AND CLOSING OF APPLICATIONS
