### Please note the following:

- If you have a current direct debit authority in place with ClubLINKS then this will continue unless otherwise advised in writing to ClubLINKS Pty Ltd c/- PGA National Office, 600 Thompson Road, SANDHURST VIC 3977, fax 03 9639 2244 or email [accounts@clublinks.com.au](mailto:accounts@clublinks.com.au) . Please ensure your account details are current. If your details require changing, please submit a new Direct Debit Authority.
- There will be 6 monthly instalments on the 15<sup>th</sup> of each month or next business day, beginning on January 15 2010 and ending on June 15 2010 (the last instalment may vary slightly due to rounding).
- The first instalment will include payment of your 2009/10 Clubhouse Levy. Your credit will be available upon confirmation of your first instalment processed which may be 2 business days after the instalment date.
- Direct Debit Service Agreement is available online – <http://www.sandhurst.com/Member%20Info/enews.aspx>
- Confirmation of your Authority will be sent via email where a valid, legible email address is provided.
- A monthly instalment administrative fee of \$5.75 will be charged for each invoice paid using the direct debit facility. Should any direct debit instalments fail, a \$50.00 admin fee may be charged, independent of bank fees, for any invalid or declined direct debit transactions. Please ensure your details are up to date with ClubLINKS in writing at all times to avoid this fee.
- The Golf Victoria Magazine, available to golf members, will be added to the first instalment, if indicated on your remittance.
- Receipting of your remittance advice may take up to 2 business days and your Clubhouse Levy credit available thereafter.
- All of the above fees are GST inclusive.

*When purchasing land from Sandhurst Golf Estates (Developer) subscription fees and levies are adjusted at settlement by your conveyance. The above options are not available.*
