

**RESIDENT REBATE APPLICATION FORM****PLEASE READ CAREFULLY**

The Board in its sole discretion may discount residential Subscription fees payable by Resident Members in the form of a rebate. The rebate will be reviewed and determined at the beginning of each financial year. Terms and Conditions of the rebate are set out below-

1. A Resident Share Holder/Member who also holds a Golf Share (Individual, Family or Corporate) or Club Lifetime Membership may be entitled to a \$550 rebate.
2. Only one rebate per Residential Share/Membership & Golf Share or Club Lifetime Membership is applicable.
3. Subscription Fees and Clubhouse Levies for both Golf & Residential Memberships must be paid either in full or by entering a direct debit plan by the due date.
4. Any outstanding subscription fees, levies or charges from prior financial years must also be paid.
5. The rebate will be applied as a credit to the Members Nominated House Account. Unused portion of rebate credits will not be forfeited at the end of the financial year.
6. An application form must be completed and returned to the Club no later the 30<sup>th</sup> September 2009.
7. Family & Corporate Shares are entitled to one Rebate per Residential Share.
8. Rebate is only available when subscription fees have been invoiced (and paid) for the period 1 July 2009 – 30 June 2010. No pro-rata rebates available.
9. An approved rebate may take up to 1 month to be processed. Confirmation of your rebate will be reflected on your monthly statement.
